Description: The overarching objective of the PrisonLIFE project is to identify criminological-penological, psychological, sociological, legal, and security aspects of the quality of prison life in Serbia to understand the contemporary experience of imprisonment and reach its objective assessment and comprehensive improvement. Additional emphasis is placed on the population of female convicts given their multiple vulnerabilities and marginalization, as they are frequently overlooked in criminological and sociological research of the convicted persons in our region.

Responsibilities: (1) Contributing to the successful implementation of the PrisonLIFE project within the theoretical-empirical analysis and assessment of possibilities for improving the quality of prison life in Serbia from the criminological-penological, psychological, sociological, legal and security aspects, followed by the development of empirically and theoretically based policy recommendation. (2) Included in an explanatory meeting with interested parties and making recommendations resulting from it, and also coordinates field research. (3) Cultural adaptation and development of the MQPL survey in Serbian and the evaluation of its psychometric properties, especially in testing its content validity.

Corruption Risk, Risk of Corruption? Distinguishing Criteria Between Petty and High-Ranking
