<p>Course aim: During the course, students will master grammatical structures, vocabulary and language skills at a level that enables them to communicate in nearly any everyday situation, as well as to discuss familiar topics spontaneously and to recount events from the past. The program also includes further extension of knowledge in the field of legal Italian, mostly vocabulary.</p>
<p>Course outcome: Acquiring knowledge and competences that correspond to the Common European Framework of Reference for Languages level A2.2, as well as the ability to understand basic legal terminology.</p>
<p>Course contents: Theory Classes: WEEK 1-4: Lesson 1: <i>In giro per negozi</i> (Shopping Around): Describing and shopping for clothes. Expressing one's taste in clothes. Comparison. Colors. Use of the verb <i>piacere</i>. Indirect pronouns: stressed and unstressed forms. WEEK 5-8: Lesson 2: <i>Quando ero piccola...</i> (When I Was Little...): Describing past situations and actions that occurred repeatedly. Talking about one's childhood. Past tense: <i>imperfetto</i>: regular and irregular verbs forms and use. <i>Passato prossimo</i> vs. <i>Imperfetto</i>. Time expressions with <i>imperfetto</i> and <i>passato prossimo</i>. WEEK 9-11: Lesson 3: <i>Un tipo interessante</i> (An interesting guy): Understanding and giving physical descriptions. Describing personality. Comparatives (minority, majority and equality) Present conditional: regular and irregular forms. Verbs <i>farcela</i> and <i>darsene</i>. Additional material of legal Italian adapted to the needs and interest of students. WEEK 12 -15: Lesson 4: <i>Ti va di venire?</i> (Do you want to come?): Making a proposal, accepting or rejecting a proposal. Progressive form with <i>stare + gerundio</i>. Agreement between direct pronouns and past participles. Additional material of legal Italian adapted to the needs and interest of students.</p>
<p>Practical classes: WEEK 1 – 15: Grammar and vocabulary exercises (clauses, endings, transformations), reading and listening comprehension exercises (multiple/double choice, open questions), oral and written expression exercises (role play, guided dialogue/monologue, composition writing), video material (integrated practice of all language skills), introduction to the basic specifics of professional legal texts in Italian, initial work on a joint project of creating a basic Italian – Serbian legal dictionary.</p>
