**Violeta Beširević** je redovna profesorka na Pravnom Fakultetu Univerziteta Union u Beogradu, pridružena naučna saradnica Centralnoevropskog univerziteta u Budimpešti/CELAB/Institut za demokratiju, pridružena naučna saradnica Centra za pravo i pluralizam Univerziteta Milano-Bikoka i članica upravnog odbora Evropske organizacije za javno pravo. Glavna je i odgovorna urednica časopisa PFUUB *Pravni zapisi*. Diplomirala je na Pravnom fakultetu Univerziteta u Beogradu, magistrirala i doktorirala na Centralnoevropskom univerzitetu u Budimpešti iz oblasti uporednog ustavnog prava. Dobitnica je Fulbrajtove stipendije. Bila je postdoktorand na Pravnom fakultetu Univerziteta Njujork (NYU Law School) na kojem je kao *Hauser Global Research Fellow* i *Fulbright Scholar* radila na istraživanju o ustavnom sudstvu. Usavršavala se na pravnim fakultetima Univerziteta Džordž Vašington i Univerziteta Brigam Jang u SAD, kao i na Institutu Aser u Hagu. Održala je gostujuća predavanja na univerzitetima u Nemačkoj, Švajcarskoj, Portugalu, Mađarskoj i Hrvatskoj. Karijeru je započela u Saveznom ministarstvu pravde bivše SFRJ kao stručni saradnik, savetnik I samostalni savetnik (1986-1994), radila je u Institutu za ustavnu i zakonodavnu praksu pri OSI i CEU u Budimpešti (1995-2001), bila je diplomata i konzul u Mađarskoj (2001-2005), kao i koordinator istraživanja u Centru za ljudska prava na Centralnoevropskom univerzitetu u Budimpešti (2005-2006). Od 2008. do 2012. bila je članica Komisije za pomilovanje. Položila je pravosudni ispit, istupala je kao *amicus curiae* pred Ustavnim sudom Srbije i kao veštak u međunarodnoj investicionoj arbitraži pod okriljem Stalnog arbitražnog suda u Hagu. Autorka je brojnih radova objavljenih na srpskom i engleskom jeziku u oblasti ustavnog prava, evropskog ustavnog prava, ljudskih prava i bioetike.
